## Testing

Florida Blue is assessing solutions that align with the industry as how to best perform ICD-10 testing with its healthcare provider community prior to ICD-10 implementation. Once testing plans are defined, information will be made available through this as well as other Florida Blue provider communication channels.

CMS is funding a one-year effort to develop a process and methodology for End-to-End testing per the requirements of the Administrative Simplification Act. While the goal is for a process to be used across all Administrative Simplification Requirements, ICD-10 will be the test case used during the pilot.
