What is the overall <u>deductible</u>?	In-Network: \$5,950 Per Person/ \$11,900 Family. Out-of-Network: \$11,900 Per Person/ \$23,800 Family.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u>?	Yes. <u>Preventive care</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply.
Are there other <u>deductibles</u> for specific services?	Yes. \$3,000 Pharmacy <u>Deductible</u> ; . There are no other specific <u>deductibles</u> . Does this plan provide Minimum Essential Coverage? **Yes**
