<b>What is the overall deductible?</b>	In-Network: Not Applicable. Out-of-Network: <b>\$500</b> Per Person/ <b>\$1,000</b> Family.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay.
