<b>What is the overall deductible?</b>	<b>\$0</b> at Indian Health Care <u>Provider</u> (IHCP) or with IHCP <u>referral</u> at non-IHCP; or <u>In-Network</u> : <b>\$5,500</b> Per Person/ <b>\$11,000</b> Family. <u>Out-of-Network</u> : <u>Not Applicable</u> .	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
<b>Are there services covered before you meet your deductible?</b>	Yes. <u>Preventive care</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without <u>cost sharing</u> and before you meet your <u>deductible</u> . <b>What is the out-of-pocket limit for this plan?</b>	Yes. <u>In-Network</u> : <b>\$8,000</b> Per Person/ <b>\$16,000</b> Family. <u>Out-Of-Network</u> : <u>Not Applicable</u> .	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. <b>What is not included in the out-of-pocket limit?</b>	<u>Premium</u> , <u>balance-billed charges</u> , and health care this <u>plan</u> doesn't cover.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .
