What is the overall <u>deductible</u>?	\$0 at Indian Health Care <u>Provider</u> (IHCP) or with IHCP <u>referral</u> at non-IHCP; or <u>In-Network</u> : \$1,500 Per Person/ \$3,000 Family. <u>Out-of-Network</u> : \$3,000 Per Person/ \$6,000 Family.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. Are there services covered before you meet your <u>deductible</u>?	Yes. <u>Preventive care</u> .
