What is the overall deductible?	In-Network: \$400 Per Person/\$800 Family. Out-of-Network: Not Applicable.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay.
