Responsible Rx Gets Added Dose of Benefits

In January, we expanded three components of our Responsible Rx pharmacy program for BlueOptions® and Health Options (BlueCare® and BlueMedicareSM HMO) members. Responsible Rx refers to an umbrella of programs including Responsible Quantity, Responsible Steps and Responsible Dose programs.

Expansion of Responsible Steps to include Byetta

Beginning in January, Byetta has been added to our Responsible Steps program. Byetta is a new medication approved by the FDA as an add-on treatment for diabetes. A prescription will *automatically* be covered as long as the member has had a claim for a metformin, a sulfonylurea, or a thiazolidinedione in the last six months.

Medications included in tablet splitting program:

Anti-depressants

Celexa 10 and 20mg Effexor 25, 37.5 and 50mg Paxil 10 and 20mg Pexeva 10 and 20mg Zoloft 25 and 50mg

Cholesterol-lowering medications

Crestor 5mg, 10mg, 20mg Mevacor 20mg Pravachol 10, 20, and 40mg Zocor 5, 10, 20, and 40mg

Anti-hypertensives

Aceon 2 and 4mg Atacand 4, 8, and 16mg Avapro 75 and 150mg Cozaar 25 and 50mg

Tablet Splitting Program Can Reduce Copay by 50%

Members can join this voluntary program, allowing them to take their medications in half-tablet doses—reducing their copay by 50%, or up to half their coinsurance.

To participate, members must meet the following criteria:

- Take at least one of the medications listed at left once daily
- Request a new prescription for double the strength, but half the quantity, of the usual prescription
- Consult their provider to determine if pill splitting is appropriate for them

In addition, the number of tablets must be exactly half of the submitted days supply (i.e. 15 tablets for a 30-day supply or 45

tablets for a 90-day supply.) Coinsurance reductions will be realized as members pay their portion on half the usual number of tablets.

In January, qualifying members were mailed an introductory letter, a tablet splitter, and a "how to" brochure detailing all the information members need to learn more about this money-saving program.

Responsible Quantity Added to MediScript

The Responsible Quantity Program has been added to all MediScript pharmacy plans, except Dimension and Conversion Option II plans. The MediScript pharmacy plan requires members to initially pay for all oral, topical or self-administered medications. Members must submit a reimbursement claim as per their policy. Participating pharmacies transmit a claim to Prime Therapeutics® and receive back the approved discounted cost of the medication.

Health Savings Accounts for 2008: Did You Know...

Members with Health Savings Accounts may now contribute up to \$2,900 with individual coverage or \$5,800 with family coverage. Individuals aged 55 or older may also contribute an additional \$900.

The Internal Revenue Service has also established health plan minimum and maximum in-network out of pocket limits for 2008:

 Individual plans: \$1,100 to \$5,600 Family plans: \$2,200 to \$11,200
